## **CONFERENCE COMMUNIQUÉ**

- We, the Commonwealth Caribbean Association of Integrity Commissions and Anti-Corruption Bodies ("the Association"), meeting at our Eighth Annual Regional Conference convened under the auspices of the Commonwealth Secretariat and hosted by the St Kitts Integrity Commission under the theme: Controlling Corruption: Preventative Mechanisms work better than Reactive Measures;
- NOTING with deep gratitude the invaluable support and warm hospitality provided by the Government and people of St Kitts and Nevis, the St Kitts Integrity Commission and the Nevis Integrity Commission; the Remarks by His Excellency, Sir S. W. Tapley Seaton, GCMG, CVO, QC, JP, LLD, Governor General of St. Kitts and Nevis in declaring the Conference open; the Hon. Vincent Byron Jr., Attorney General of St Kitts and Nevis for his Remarks and for deputizing for Dr. The Hon. Timothy Harris, Prime Minister at the Opening Ceremony; Dr. The Rt Hon. Denzil Douglas, former Prime Minister of St Kitts & Nevis for his Remarks at the Opening Ceremony; and the Rt. Hon. Baroness Patricia Scotland QC, Commonwealth Secretary-General who was present and delivered an Address at the Opening Ceremony;
- 3) **RECOGNIZING** the need to continue to use this regional platform for the sharing and implementation of best practices and strategies for combating corruption, and the promotion of good governance;
- 4) **HAVING** extensively discussed the theme of the conference and its programme content, with a full exchange of views of presenters, panellists and participants;

## **AGREED AND ADOPTED** the following resolutions: -

a. continue to reiterate the need for regional Integrity Commissions and Anti-Corruption Bodies to maintain their independence, impartiality and professionalism, to further enhance their effectiveness;

- make relevant recommendations to our respective Governments with a view to modernizing, enacting, and bringing into operation relevant legislation to continuously combat corruption;
- c. continue our calls on Member Governments to provide adequate financial, technical, and other resources (human or otherwise) to the Integrity Commissions and Anti-Corruption Bodies, and to facilitate greater autonomy in the use of those resources by the said Commissions and Bodies:
- d. urge governments to enact, expand and implement national legislative frameworks and strategies for improved effectiveness, so that there are no legislative silos which deter holistic Integrity Commission and Anti-Corruption work;
- e. urge governments of the Commonwealth Caribbean to do whatever is necessary to ensure that respective Commissions are fully constituted and functional; and further urge that when vacancies occur that they be filled expeditiously;
- f. plan for the Association to establish a permanent secretariat, and employ an Administrative Secretary on a part-time basis;
- g. invite CARICOM and other internationally recognized organizations to collaborate with CCAICACB in anti-corruption efforts, integrity building and capacity building;
- h. foster greater networking and coordination among national and regional agencies to strengthen anti-corruption work;
- continue our work based on the premise that Preventative Measures are complimentary to Enforcement, Investigations, Litigation and Asset Recovery;
- j. place greater emphasis and provide more resources on Preventative Measures and Public Education;
- k. advocate that anti-corruption is placed in curricula in formal education systems, being mindful that public and formal education enhance desirable behavior patterns and help to sustain cultural shifts at all levels;

- utilize traditional and social media effectively to promote anti-corruption messages and work;
- m. encourages Churches to intentionally espouse and require honesty from their membership and the society at large
- n. require member countries to make every effort to improve their score on corruption indices
- o. encourage governments to analyze and streamline procurement processes as a means to proactively prevent corruption;
- p. promote and embrace blockchain technology as an excellent means of preventing corruption;
- q. encourage governments to develop, implement, review and update Codes of Conduct, to reduce conflicts of interest and promote an ethical culture;
- r. adopt effective and relevant organizational risk management strategies and information gathering techniques;
- s. seek the technical assistance and support of the Commonwealth Secretariat and request that the Commonwealth Secretariat provide further education on the adoption of the 22 Anti-Corruption Benchmarks;
- t. continue to mobilize youth to understand the importance of integrity and ethics and the causes and effects of corruption on our society;
- u. to adopt the life cycle approach to anti-corruption and educate persons from cradle to grave;
- v. promote the work of each Member Country through the use of internet platforms such as dedicated websites;
- w. support each Member Country in its anti-corruption and integrity work within the unique context of each Country; and
